

Charges included actual or attempted sexual contact more than once against a 7 year-old girl who he was familiar with. The crimes involved coercion and physically overpowering his victim. He was sentenced to 5 years in state prison.



**Liston, Gregory** - 6 Marne Avenue. DOB 2/3/1985. Convicted of Possessing Sexual Performance by a Child Less than 16. He was arrested by the New York State Police following the crime in 2020 and he was convicted in 2022. Charges included promoting and/or possessing sexual performance by a child. He was sentenced to 4 months in county jail.



**Seuffert, Phillip** - 316 Broadway, Room #251. DOB 9/3/1989. Convicted of Criminal Sexual Act in the 1st degree - Victim Less than 11 Years Old. He was arrested by the New York State Police following the crime in 2008 and was convicted in 2010. Charges included actual sexual contact with an 8 year-old boy who was a stranger. He was sentenced to 8 years in state prison.

Charges included actual sexual intercourse, actual deviate sexual intercourse, actual sexual contact, and promoting/possessing sexual performance by a child. He allegedly used a threat of force. He was arrested by the NYSP and received 150 months in state prison.



**Dabbs, Julius** - 507 Cortland Drive. DOB 1/16/1962. Convicted of Sexual Abuse 1st against a 10 year-old girl in Peekskill in 2002. The charges included actual sexual intercourse, actual deviate sexual intercourse, and actual sexual contact. He allegedly physically overpowered his victim, and used threats and coercion. He received 2-4 years in state prison.



**Ferdon, Anthony** - 537 Fostertown Road. DOB 6/26/1988. Convicted of Sexual Misconduct against a 14 year-old girl in Middletown. Charges included using coercion for actual sexual intercourse more than once and actual sexual conduct. He received 6 years probation.



**Forte, William** - 37 Albany Post Road. DOB 4/1/1966. Convicted of Sodomy 1st and Possessing an Obscene Sexual Performance by a Child in NYC in 2002. Charges include actual sexual contact more than once and promoting/possessing sexual performance by a child more than once. The victim was a 13 year-old boy. He received 60 months to 4 years in state prison.



**Gardner, Patricia** - 2501 Barclay Manor. DOB 1/31/1963. Convicted of Rape 2nd against a 13 year-old boy in Middletown in 2001. Charges included actual sexual intercourse more than once and disseminating indecent materials to a minor more than once. She received 18-54 months in state prison.





**Anderson, Rusty** - 90 Robinson Ave. DOB 9/28/1977. Convicted of Criminal Sexual Act 2nd against a 14 year-old girl in Port Jervis in 2016. He received 5 years in state prison.



**Avila, Angel** - 354 Washington Street, 2nd Floor. DOB 6/18/1986. Convicted of Rape 2nd against a 15 year-old girl in New Windsor in 2007. He received 16 months to 4 years in state prison.

He received 4 years in state prison. Incident #2: Convicted of Criminal Sexual Act 2nd against a 13 year-old boy in Port Jervis in 2019. The charges included actual deviate sexual intercourse more than once and actual sexual contact more than once. He received 2 years in state prison.



**Carlini, Joseph** - 45 Dubois Street, 1st Floor. DOB 12/25/1961. Convicted of two counts of Rape 3rd, one count each of Rape 2nd, Criminal Sexual Act 3rd, Sexual Abuse 3rd, Criminal Sexual Act 2nd. The charges included actual sexual intercourse more than once against a 13 year-old girl and a 16 year-old girl in 2002. He was arrested by the NYSP and received 28 months to 7 years in state prison.



**Beamon, Thomas** - 11A South Johnson Street. DOB 8/12/1955. Convicted of Attempted Criminal Act 1st against a 11 year-old girl in 2007. He was arrested by the NYSP for actual sexual contact using coercion. He received 42 months in state prison.



**Brennan, Orlando** (aka Orlando Gonzalez) - 223 First Street, 2nd Floor. DOB 11/12/1969. Convicted of Rape 1st against a 10 year-old girl in Orange County. Charges included actual sexual contact and intercourse using coercion. He received 8 years in state prison.

**Incident #1 of 2:** Convicted of Sexual Abuse 1st against a 9 year-old girl in Middletown in 1998. Charges included deviate sexual intercourse and actual sexual contact. He received 3-6 years in state prison.

**Incident #2 of 2:** Convicted of two counts of Criminal Sexual Act 1st against a 13 year-old girl in Middletown in 2004. He received 10 years in state prison.



**Donnelly, Elizabeth** - 165 Broadway, Apt 2-3. DOB 7/6/1992. Convicted of Course of Sexual Conduct Against a Child 2nd against a 10 year-old girl in Port Jervis. Charges included actual deviate sexual intercourse and actual sexual contact. She received 10 years probation.



**Duggan, Joshua** - 13 1/2 Liberty Street, Apt 1. DOB 7/1/1962. Convicted of Rape 1st Forcible Compulsion and Sexual Abuse 1st against a 13 year-old girl and a 14 year-old girl in Orange County in 1991. Charges included actual sexual intercourse and actual sexual contact while physically overpowering his victims, striking them, and threatening them. He received 100 months to 25 years in state prison.

Convicted of Rape: Intercourse Female Physically Helpless; Sodomy: Intercourse Female Physically Helpless; and Sexual Abuse 1st: Person Incapable of Consent.
