Shooting

On October 27, 2022, at about 10:05 P.M., City of Newburgh Police Officers received multiple calls for shots fired inside a residence in the area of City Terrace and Van Ness Street. Upon arrival, officers learned that a 45-year-old Newburgh resident had sustained two gunshot wounds – one to his upper chest and one to his right arm. Officers immediately rendered medical assistance and the victim was transported to St. Luke's Hospital for treatment. He is in critical but stable condition at this time.

There are no known suspects at this time. Police are looking for any witnesses who may have been in the area at the time of these incidents. Anyone with any information is asked to call the City of Newburgh Police Department at 845-569-7509. Callers can remain anonymous.

Shooting at Newburgh Free Academy (NFA) school parking lot

On Friday, 09/30/22 at approximately 9:35 p.m. officers working security at the NFA football game heard gunfire in one of the north parking lots as attendees were exiting the stadium. The Police Department was additionally alerted to gunshots by a SHOTSPOTTER activation. Arriving officers were on-scene instantaneously and located three victims suffering from gunshot wounds:

- One victim was a 43-year old Female who was shot in the foot.
- Second victim was a 19-year old female who was shot in the thigh
- Third victim was a 21-year old male who was shot in the ankle.

(All three victims are City of Newburgh residents)

Officers and Mobile Life Support EMS rendered aid to all three victims and transported them to St. Luke's where they are being treated for non-life threatening injuries.

No arrests have been made. CNPD is looking to identify the two below pictured individuals as persons of interest. If you know their identity or have any information, you are asked to contact the City of Newburgh Detective Division at (845) 569-7509. Callers can remain anonymous.

Shooting Homicide

On Thursday evening 09/29/22 at approximately 7:07 p.m. officers on patrol heard gunfire in the area of Washington Street and Clark Street. The Police Department was additionally alerted to gunshots by a SHOTSPOTTER activation in the area of the 100 block of Washington Street. Arriving Officers located two victims suffering from gunshot wounds. One victim was a 5-year-old child that had been riding his bicycle and sustained a gunshot wound to his leg. The second male victim was a 29-year-old City of Newburgh resident that had been shot multiple times. Both victims were transported in police cars to St. Luke's Hospital, where the 29-year-old victim succumbed to his injuries and was pronounced dead.

The 5-year old child was airlifted to Westchester County Medical Center with non-life threatening injuries. The identities of the victims, who are not related, will not be released at this time.

Police Commissioner Jose A. Gomerez visited with the child and his mother at the hospital and remarked *"It is disheartening to see this child's innocent face lying in a hospital bed, crying in pain. As a community we need to take a stand against gun violence and demand we put a stop to the trauma that continues to be inflicted on our children, our youth and our City."*

Multiple Illegally Possessed Firearms Recovered

During the week of August 15, 2022, City of Newburgh Police Officers and the New York State Police recovered six illegally possessed handguns as follows from the area of 104 William Street:

- Smith & Wesson .38 Special Airweight Revolver
- Smith and Wesson .40 SD40 VE Semi-Automatic Pistol
- Defaced 9mm Glock 43X Semi-Automatic Pistol
- 9mm Glock 17 Semi-Automatic Pistol
- Phoenix Arms .22 Caliber Semi-Automatic Pistol
- Polytechnologies P80 9mm Semi-Automatic Pistol

Additionally, a large quantity of money and illegally possessed narcotics were recovered.

Davon Waddell (a 24-year-old Newburgh resident), Aljean Cromartie (a 20-year-old Newburgh resident), and Palmis Byrd (a 28-year-old Newburgh resident) were all charged with Criminal Possession of a Weapon in the Second Degree, as well as other appropriate charges.



Homicide

On August 08, 2022, at about 1:26 a.m., City of Newburgh Police Officers received multiple direct calls for shots fired in the area of 32 Benkard Ave. While officers were responding to the area, they received another call for service in the area of 211 Liberty Street for a rollover motor vehicle accident. Officers located the victim, a 39-year-old Newburgh resident, entrapped in a vehicle that had been shot multiple times. The City of Newburgh Fire Department extricated the victim, who had sustained a gunshot wound to his right upper back and was unconscious/unresponsive. Officers and Mobile Life Support Services began CPR, attempted to render lifesaving aid, and transported the victim to St. Luke's Hospital where he was ultimately pronounced deceased. Officers located six expended shell casings in the area of S. Lander Street and Benkard Avenue.

On July 27, 2022, at about 11:59 p.m., City of Newburgh Police Officers received a Shotspotter activation in the area of 207 Lake Drive for five rounds. Officers located a victim, a 29-year-old Newburgh resident, in the area of 177 Lake Drive who had sustained two gunshot wounds – one to his upper chest, and another to his bicep. Officers immediately performed CPR and attempted to render lifesaving aid. The victim was transported to St. Luke's Hospital, where he was ultimately pronounced deceased.

Shooting Incident

On July 23, 2022, at about 1:33 a.m., City of Newburgh Police Officers received a Shotspotter activation in the area of 79 Liberty Street for five rounds and a second Shotspotter activation less than a minute later in the area of 90 Washington Street for four rounds. Officers located nine expended shell casings in the area of 77 Liberty Street. A 28-year-old male Newburgh resident was shot in the ankle and sustained non-life threatening injuries.

Shooting Incidents

On July 20, 2022, at about 11:12 p.m., City of Newburgh Police Officers received a Shotspotter activation in the area of 100 William Street for 21 rounds. Officers located 21 expended shell casings of varying calibers - .40, 9mm, and .380 casings – which indicated that at least three separate handguns had been fired during the incident. At least two vehicles were struck by gunfire, and a 36-year-old male was shot at least once and sustained non-life threatening injuries to his neck and his back.

While officers were processing the aforementioned shooting scene, they received another Shotspotter activation in the area of Johnston Street and Campbell Street for 16 rounds. Officers located a total of thirteen .40 expended shell casings in the area. At least one vehicle was struck by gunfire, but there are no known shooting victims at this time.

Shots Fired Incidents – Gun Possession Arrests

On July 5th, 2022, around 1:00 A.M., police received a ShotSpotter notification for the North Miller block. Officers arrived and located twenty shell casings consisting of .40 caliber, .45 caliber, and 9mm. In addition, officers located several live .40 caliber and .45 caliber rounds. Officers continued to canvass and located an additional twenty-two 9mm shell casings a few houses away from the initial scene.

While officers were processing the second scene, ShotSpotter notified officers of another shooting about two blocks away, in the Farrington block. Officers responded and located two shell casings and a vehicle that was struck by gun fire.

Officers continued to process all three scenes and located a total of two loaded firearms, a Hi-Point .45 semi-automatic firearm and a Smith & Wesson .38 revolver (both pictured below).

On July 15th, 2022, the City of Newburgh Police Department arrested two suspects involved with this incident. Deandre Peacock, a 22-year-old City of Newburgh resident, and Deon Patterson, a 21-year-old City of Newburgh resident, were both arrested and charged with Criminal Possession of a Weapon 2nd.

Weekend Shooting Incidents

On June 25, 2022, at 3:00AM two Beacon residents arrived at Montefiore St. Luke's Cornwall General Hospital for gunshot wounds. One victim was male and the other was female, both are 23 years old. The female victim was shot in the foot and the male victim was shot in the calf. At this time a location for this shooting has not yet been identified.

On June 26, 2022, at 11:55PM ShotSpotter notified police of 4 rounds fired in the 200 block of Lander Street. The City of Newburgh Mobile Police Precinct stationed at Liberty Street and South Street also heard the shots and responded on foot. A 17 year old City of Newburgh resident was identified as the victim. The victim was taken to Montefiore St. Luke's Cornwall General Hospital for a gunshot wound to his back. The victim was later transported to Westchester Medical Center.

Multiple Shootings, Stabbing

On June 11, 2022, at about 12:05 A.M., the City of Newburgh Police Department received a ShotSpotter activation in the area of Liberty St and Lafayette St for multiple shots fired. Officers located a 49-year-old male Newburgh resident who had been shot once in his ankle in the area of the Terrace Tavern. He was transported to St. Luke's Hospital for treatment and is in stable condition at this time. Officers cleared this scene for a second ShotSpotter activation.

At about 12:17 A.M., officers received another ShotSpotter activation in the area of Mill St and S. William St for multiple shots fired in the area of El Tropical bar. Officers located two gunshot victims – a 24-year-old Newburgh resident who had been shot once in the lower back/buttocks area, and a 23-year-old male Newburgh resident who had been shot once in the right leg. Additionally, a 27-year-old male Newburgh resident sustained a laceration to his right hand. Both gunshot victims were transported to St. Luke's Hospital for medical treatment. The 24-year-old victim is in stable condition, and the 23-year-old gunshot victim was transferred to Westchester Medical Center for advanced medical care.

At about 12:15 A.M., officers received a call from St. Luke's Hospital for a stabbing victim that had been transported to the hospital via private vehicle. Officers learned that an 18-year-old male Newburgh resident and an 18-year-old female Newburgh resident had been attacked in the area of the Newburgh ferry parking lot. The male victim sustained two puncture wounds in his upper back and was treated at St. Luke's Hospital.

At about 1:34 A.M., officers received another ShotSpotter activation in the area of 29 S. Water St (the Newburgh ferry parking lot) for 8 shots fired. Officers located 8 expended shell casings in the area. Officers learned that a 17-year-old female Newburgh resident had been shot once in her right leg and was transported to St. Luke's Hospital for medical treatment via private vehicle prior to police arrival. She is in stable condition at this time.

On April 26, 2022, at approximately 12:58 a.m., Officers responded to a ShotSpotter activation in the area of Washington St. and S. On April 25th, 2022, at approximately 2:20 p.m., City of Newburgh Police Officers were flagged down in the area of Renwick Street and South Clark Street for a robbery. Officers obtained a description of the suspects in the incident, and a group of males that matched the description was quickly located by responding officers.

When officers attempted to stop the group of males, they immediately ran from the officers on foot. As officers ran after the males, both males were reaching for their waist area and appeared to be grabbing for an object. Officers watched one of the males discard a firearm. Two male suspects were apprehended and two firearms were located, a 9mm Polymer 80 PF940C (an untraceable “ghost gun” with no serial number) and a 9mm Springfield Armory Hellcat.

One of the suspects, a 17-year old juvenile, was charged with Criminal Possession of a Weapon in the Second Degree. This incident is still under investigation.

On March 28, 2022, at 9:07 a.m., City of Newburgh Police officers were investigating an incident in the area of Gidney Ave. and N. Robinson Ave. Officers observed a male in the area of 245 Third St who matched the description of the suspect.

Officers detained the suspect (later identified as Miguel Cruz-Nava, a 26-year-old Newburgh resident) pending further investigation and located a Ruger Model EC9 semi-automatic pistol that contained nine bullets in his waistband. The firearm had been reported stolen from Lancaster, Pennsylvania.

Mr. Cruz-Nava was ultimately charged with Criminal Possession of a Weapon in the Second Degree, which is a Class C Felony.

On March 15th, 2022, at 8:10 p.m., the City of Newburgh Police responded to the area of South St. and Lander St. for a ShotSpotter notification. Officers arrived on scene and recovered four expended shell casings. While canvassing officers also recovered a projectile in a parked (unoccupied) vehicle's headrest and a projectile on the sidewalk on Lander St.

On March 15th, 2022 at 9:58 p.m., the City of Newburgh Police received another ShotSpotter notification in the area of 33 Clark Street indicating that 13 rounds had been fired. The Police Department also took several direct calls from residents reporting the gunfire.

Officers arriving on scene located 13 expended shell casings and identified two vehicles and two residences that had been struck by gunfire. One vehicle was occupied at the time of the incident by a male and a female who were uninvolved and caught in the middle of the gunfire. The female was struck by shrapnel that traveled through her seat. The female did not seek medical treatment.

On March 15th, 2022, at 07:08 a.m., Officers were dispatched to the area of Van Ness St. and Carpenter Ave. for an assault. The victim was bleeding profusely from lacerations to his face and hand. Officers rendered medical treatment by applying a tourniquet and bandages to control bleeding until an ambulance arrived, at which time he was transported to St. Luke's Hospital.

Initial interview revealed the incident was domestic in nature and occurred in the driveway of the victim's residence when the suspect, who was identified as Rafael Carrera, initiated a verbal argument with his father while his father was sitting in his vehicle while the vehicle was parked in the driveway. Carrera became agitated, assaulted the victim with a knife, then fled the scene on foot. The knife used in the incident has not been recovered.

On March 14th, 2022 at 12:54 am City of Newburgh Patrol Officers observed a black BMW rapidly fleeing from the parking lot of a bar located at 411 Broadway and initiated a traffic stop. It was determined that the operator had been involved in an altercation just outside the bar and suffered a non-life threatening stab wound to his right hand. The victim is a 34 y/o City of Newburgh resident that was treated on scene and transported to a local hospital for treatment.

Investigating Detective and Officers were able to locate a crime scene and identify a suspect in this incident in the parking lot of 411 Broadway. The knife believed to have been used in the assault has also been recovered.

On February 11, 2022, the City of Newburgh Police Department and the New York State Police were conducting a joint Precision Policing Initiative* detail.

At 4:16 p.m. City of Newburgh Police Officer Jodice was patrolling with his New York State Police partner when they noticed a male wanted for questioning in regards to a recent shooting incident that occurred on February 6th, 2022, on Mill St. Officer Jodice and his partner attempted to stop the individual in the area of Renwick St and South Clark St when the suspect fled on foot leading Law Enforcement in a foot chase. The suspect ran inside a local first floor residence on Benkard Ave in an attempt to evade law enforcement. Law Enforcement continued to pursue, catching up to the suspect inside a rear bedroom where a struggle ensued. Ultimately the suspect was taken into custody and a loaded 9mm Taurus semi-automatic handgun was recovered. The handgun was loaded with a high capacity magazine and a laser attachment.

The suspect was identified to be James D. Boursiquot, a 25 year old Newburgh resident. Mr. Boursiquot was charged with Felony Burglary, Felony Weapons Possession, Misdemeanor Drug Possession, and other related offenses. Mr. Boursiquot was also charged with Felony Weapons Possession offenses related to the February 6th, 2022, shooting incident on Mill St.

On January 18, 2022 at approximately 9:19 a.m., the City of Newburgh Police Department responded to 97 Fullerton Avenue for report of a shooting.

Officers arriving on scene located a 27-year old male victim and City of Newburgh resident who sustained two gunshot wounds (one to his leg and one to his back). Officers performed life-saving measures, before the victim was transported to St. Luke's Hospital for further evaluation. On January 8, 2022 at approximately 7:28 a.m., the City of Newburgh Police Department responded to 56 Van Ness Street for report of an assault in progress.

Officers arriving on scene located a 50-year old female victim who was struck in the head with the butt of a folding knife and a 47-year-old male victim who had been stabbed in the hand and arm. Officers were informed that the male-perpetrator was still inside the building, and was also suffering from stab wounds that were sustained during the physical altercation.

The perpetrator, identified as 54-year old Charles McLean was located at the top of the staircase holding a knife threatening officers not to come near him or he would kill them. A standoff ensued and following approximately three hours of hostage negotiations, McLean was placed in-custody without further incident.

McLean was transported to Montefiore St. Lukes Hospital to be treated for stab wounds he received to his upper body and discharged. McLean was arrested and charged with Attempted Murder 2nd and Assault 2nd; with additional charges pending.

The 47-year old male-victim was transported to Montefiore St. Lukes Hospital and treated for his stab wounds/lacerations and released.

The 50-year old female-victim sustained substantial pain and swelling to her forehead and was treated at the scene.

On January 7, 2022 at approximately 12:05 a.m the City of Newburgh Police Department received a ShotSpotter notification for the area of Overlook Place and South Lander Street. ShotSpotter was indicating 19 rounds had been fired.

Officers arriving on scene located 21 shell casings on the street, several vehicles that had been struck by gunfire and were notified that two victims had been transported to a local hospital by private vehicle. One victim is a 17 year-old-male who is a Newburgh resident was struck at least once in the face and once in the torso. He was transported to Westchester Medical Center where he was admitted to the ICU in critical condition. The second victim is an 18 year-old male who is also a Newburgh City resident, was struck once in the buttocks. He was treated at Montefiore St. Lukes Hospital and discharged.

The City of Newburgh police are investigating this incident along with the Orange County Sheriff's Office and the Orange County District Attorney's Office.

On January 6th, 2022 at approximately 3:19 p.m. City of Newburgh Police Officer Ambrosetti and New York State Trooper Richichi, while working the Precision Policing Initiative, effected a Vehicle and Traffic Stop with in the area of Broadway and Lander Street.
